If you received a citation from either the Milwaukee County Sheriff's Office or State Patrol, the Milwaukee County District Attorney's Office is willing to resolve your case today with one or more of the offers listed below. If you accept an offer, you must plead "Guilty" or "No Contest" to the amended charge. Please make the Court aware of which offer you are accepting. If you choose to reject the offer, you must enter a "Not Guilty" plea and you will be given a court date in the trial court. If you reject these offers and ask to have your case continued to the trial court, the offers below are withdrawn. There is NO guarantee that any offer will be extended to you in the trial court. Please review your violation and decide what plea you will be entering BEFORE your case is called.
